This bid is subjected to the Contract Participation Goal in line with Unizulu BBBEE policy. Bidders with a turnover in excess of R15 million per year are compelled to subcontract 30% of the value of the contract to a company that is 50.1% black owned and is classified as a Qualifying Small Enterprise (QSE) or Emerging Micro Enterprise (EME). Bidders who fail to meet this requirement will be disqualified.
