AM proud to announce that the Council on Higher Education (CHE) has confirmed full accreditation for the LLB programme in the Faculty of Commerce, Administration and Law at the University of Zululand (UNIZULU).

The CHE is the statutory body responsible for quality assurance in higher education in South Africa and thus responsible for accreditation and review of higher education qualifications.

In 2012 the CHE, in conjunction with the South African Law Deans' Association and in consultation with the organised legal professions, worked on the development of a national standard for the LLB qualification, against which all faculties and schools had to evaluate their offerings.

University of Zululand made an important announcement that it would work tirelessly towards an improvement plan to ensure continuity of the LLB programme there was speculation and uncertainty.

reviews and re-accreditation. In 2018 the LLB programme and the Accounting programme were both re-evaluated by CHE and South African Institute of Charted Accountants respectively.

These quality-driven processes have ensured that the various departments reconceptualise the way in which knowledge and sources of knowledge are organised, valued and represented within the respective disciplines.

Law and Accounting programmes have been adapted to the requirements of the professional bodies in relation to the ethical development of their disciplines in a democratic society.

There has been a concerted effort by these departments to add technological innovations in the learning process and

The outcome stated that based on the evidence provided, the HEQC revised its accreditation decision to full accreditation for the Bachelor of Laws (LLB) programme offered at UNIZULU.

Deputy Vice-Chancellor overview on UNIZULU curriculum renewal and transformation

THE University of Zululand (UNIZULU) was mandated by the government to convert to a comprehensive university during the merger of universities. As such, the university recognises the need to transform the curriculum in line with this new mandate.

According to the university's strategic plan, the aim is to have a broad spectrum of programmes characteristic of a comprehensive university and to review, develop and implement review findings in existing curricula. In this regard, the university has embarked on curriculum renewal to increase career education programmes.

The Faculty of Commerce, Administration and Law focuses on four key drivers of curriculum transformation which

- responsiveness to social context;
- encouraging epistemic diversity;
- $\bullet\,\mbox{renewal}$ of pedagogy and teaching practices;
- culture of openness and

reflection. The successful accreditation of the LLB and Accounting programmes is a result of quality-driven processes that have ensured that various departments reconceptualise the way in which knowledge and sources of knowledge are organised, valued and represented within the respective disciplines

Law and Accounting have been active in interrogating the requirements of their professional bodies in relation to the ethical development of their disciplines

in a democratic society. In the Faculty of Commerce, Administration and Law, the introduction of electives at level 4 has improved the diversity of the curriculum of the LLB programme. A list of possible electives is displayed at the end of each year and level 3 students are asked to indicate



which elective they are likely to pursue at level 4. This serves as a way to assess students' needs and preferences.

This strategy enables students to get into career paths that suit them, especially students who have bursaries from municipalities and South African Revenue Service. The alumni feedback that was made available during the recent LLB review, conducted by the CHE, is available as evidence.

In addition, the LLB pro-

gramme is one of the few law programmes countrywide to offer four legal skills modules that plays a huge role in equipping students with the skills to contribute to society and be effi-

cient legal professionals. The student voice has played a huge role in the success of the LLB programme. Through Faculty councils' and the Student Representative Council's attention to academics, instances of bias and alienation related to the curriculum are discussed.

The Faculty of Commerce, Administration and Law traditionally relied on class representatives to give feedback about the programmes being offered or undergoing renewal.

UNIZULU recognises that a transformed and transformative culture that optimises the growth and potential of all staff and all students is core.

The university would like to thank the team that was responsible for enabling the institution to get full accreditation.

According to Mthokozisi Khuzwayo, a fourth-year LLB student and member of the Law Students' Council, the notice of the withdrawal of the re-accreditation of the institution's LLB course towards the end of 2017 caused anxiety among stu-

dents. "As student leaders, we remained calm and tried to allay the panic of our classmates as this evaluation was going to be beneficial to current and future law students in ensuring that the LLB qualification was of good quality," Khuzwayo said.

He added that the latest outcomes of the Council on Higher Education (CHE) national review of the LLB programme prove that the quality of education offered at UNIZULU was excellent. "The fact that we are studying in a rural-based institution does not make us inferior. Intellectual capacity is not measured by historical
